AN ORDINANCE RELATING TO THE STORAGE, RECYCLING, AND DESTRUCTION OF TOXIC AND HAZARDOUS WASTE IN OWEN COUNTY, KENTUCKY

WHEREAS, the Fiscal Court of Owen County, Kentucky deems it necessary to enact this ordinance to protect and preserve the health, safety, welfare, and convenience of the inhabitants of Owen County pursuant to the Fiscal Court's authority under KRS 67.083;

NOW, THEREFORE, BE IT ORDAINED AND ENACTED BY THE FISCAL COURT OF OWEN COUNTY, KENTUCKY, THAT:

SECTION I

DEFINITIONS: As used within this ordinance the terms "toxic waste" and "hazardous waste" shall mean those materials or substances which are defined or classified by the United States Environmental Protection Agency and/or the Commonwealth of Kentucky, Cabinet of Natural Resources and Environmental Protection as "toxic waste" or "hazardous waste" and those hazardous or toxic wastes which are classified and enumerated in the Federal Register, Vol. 45, No. 98 dated Monday, May 19, 1980; Vol. 45, No. 229, dated Tuesday, November 25, 1980; and Vol. 46, No. 11, dated Friday, January 16, 1981, and as such departments, cabinets, or agencies may modify said lists or classifications from time to time henceforth.

SECTION II

STORAGE, RECYCLING, DESTRUCTION OF "TOXIC WASTE" AND "HAZARDOUS WASTE": It shall be unlawful for any person, corporation, or any other legal entity to transport and/or otherwise bring into the County of Owen any "toxic waste" or "hazardous waste" for the purpose of its storage, recycling, reclaimatio destruction process, landfilling, incineration, or other storage.

SECTION III

PENALTY: Any person, corporation, or other legal entity who violates any provisions of this ordinance shall be fined not less than one hundred dollars nor more than five hundred dollars, and each day that a violation continues, shall constitute a separate offense for which a citation, complaint, or information may be issued and a fine imposed.
